Halstead's Spring Waterfront Report takes a look at Lower Fairfield County's most recent L.I. Sound waterfront sales data and trends.

Waterfront activity started with a bang in 2019 with a \$48 million closing in February. The sale, a Halstead exclusive, (see property details, right), was the highest closing price in Lower Fairfield County since 2014 when another Greenwich waterfront estate, on 50 acres, sold for \$120 million. In the first four months of the year, there were four waterfront closings with a sold price over \$5 million—two in Greenwich, and one in both Darien and Westport.

Throughout all price points, recent demand has been strong. There were 79 L.I. Sound waterfront house closings in Lower Fairfield County between January 1, 2018, and April 30, 2019, with an average selling price of \$4.3 million.

The closing price in February for a Greenwich water-front home on 4-acres, in a guard-gated community, with 12,000 sq. ft., a tennis court, pool, and dock. The property was an off-market, Halstead exclusive.













Closings Over \$5 Million, L.I. Sound Waterfront, 2018-2019*







Number of Lower Fairfield County L.I. Sound Waterfront House Closings by Month, 2013-2018










